

## Remote education expectations checklist

teach a planned and well-sequenced curriculum so that knowledge and skills are built incrementally, with a good level of clarity about what is intended to be taught and practised in each subject	Books are carefully levelled and support incremental skill building
provide frequent, clear explanations of new content, delivered by a teacher in the school or through high-quality curriculum resources or videos	The library can be used to provide independent work that supports teaching
gauge how well pupils are progressing through the curriculum, using questions and other suitable tasks and set a clear expectation on how regularly teachers will check work	
enable teachers to adjust the pace or difficulty of what is being taught in response to questions or assessments, including, where necessary, revising material or simplifying explanations to ensure pupils' understanding	Children can be directed to higher or lower level books as appropriate
plan a programme that is of equivalent length to the core teaching pupils would receive in school, ideally including daily contact with teachers

## How the Oxford Owl eBook Library can be used to support Remote Education without infringing copyright

The following uses apply only during the C19 pandemic when face-to-face contact with some or all pupils is not possible. The uses listed below are only allowable for use with pupils, and their parents/carers, who are current members of the purchasing school.

## Schools are entitled to use the resources in the following ways:

- ✓ Teaching sessions using any titles in the Oxford Owl eBook Library can be broadcast live to remoteaccess pupils and their parents/carers, within the purchasing school in private sessions within a closed channel (a school network, an educational platform such as Google Classroom, or video conferencing software, such as Zoom).
- ✓ Teaching sessions using up to 20% of the library's titles can be live-recorded or screen-recorded for use at a later point by remote-access pupils and their parents/carers, within the purchasing school and shared within a closed channel.
- ✓ Where a MAT, group or partnership of schools is working together, resources may be shared in the above ways only with schools who have a current subscription to the Oxford Owl eBook Library.

## Schools are not entitled to:

- X Store any recorded or scanned materials long-term. All such materials must be destroyed at the end of the C19 pandemic or by 31 July 2021, whichever is sooner, when classroom teaching resumes.
- X Make available any live broadcasts, recorded or scanned materials in a public platform (such as YouTube (unless it is on a private channel), Twitter or the school website) which could be accessed by individuals outside of the purchasing school.
- Make or permit any further use of the content if OUP terminate this permission, which it is entitled to do at any time.
